NOTIFICATION FOR PERSONAL DATA PROCESSING

Pursuant to "Regulation (EU) 2016/679 on the protection of natural persons with regard to the processing of personal data", we inform you that General State Archives (GSA) of Greece – Central Service, (61 Dafnis str., 15452, Psychiko, Tel:+3021067822008, fax: fax:+30 210-6782215, email: anagnostirio@gak.gr) acts as a controller with regards to the collection and processing of your personal data stated in the forms of GSA Reading Room (name, citizenship, identity card or passport, occupation or profession, permanent address, telephone, contact address, contact telephone, e-mail address) for the purpose of compliance with its legislative framework (see 4610/2019 law). In particular, processing your personal data, through registration in an automated system, ensures access to the archives and collections available in the Reading Room at the GSA, while it guarantees the security of the use of the archival material. In addition, anonymous data processing is performed for statistical reasons.

Your personal data is retained for security reasons of the archival material.

As a data subject you can exercise the rights provided by the provisions of the Regulation 2016/679. In particular, you have the right to request access to your personal data from the controller, meaning that the GSA shall provide you with a copy of your personal data which is processed by the GSA. Furthermore, you can exercise the rights of rectification or erasure or restriction of processing of personal data stated in the forms of GSA Reading Room. In case you submit a deletion statement for your personal data, access to the files and the collections available in the GSA Reading Room will no longer be possible.
